Association of Senates, Shoora and Equivalent Councils in Africa and the Arab World



Excerpts from speeches delivered during the 8thConference of ASSECAA, Addis Ababa-Ethiopia, 5- 6 April 2014 on the Occasion of 10th Anniversary of ASSECAA.

Introduction:

The celebration of the 10th anniversary of ASSECAA in Addis Ababa from 5th to 6th of April, 2014 is considered to be a special occasion at which the speakers / Presidents of Councils/Senates and Heads of delegations evaluated the achievements of ASSECAA during the past decade in the light of the principles and objectives for which ASSECAA was established, more particularly the objective which is related to enhance the political, socio -economic and cultural cooperation between Africa and the Arab World.

We have the pleasure to introduce some excerpts from the speeches of the participants and delegates during the Celebration of the 10th anniversary of ASSECAA on the sideline of the 8thConference held in Addis Ababa, in the Federal Democratic Republic of Ethiopia from 5th to 6th of April, 2014, that reflects their views, evaluations and aspirations of member Councils/Senates, as well as excerpts from the speeches of leaders and founders of ASSECAA.

"Today, as we celebrate the tenth anniversary of the establishment of the Association, we thank God for the favours he bestowed upon us, as He helped us right down the line. We confirm the importance of what has so far been achieved since the creation of the association with respect to enhancing its role in extending a robust bridge for consolidating the bonds of economic and sustainable cooperation, joint action among Arab and African countries as well as the attainment of the noble objectives and principles for which the association was founded.

I would like to draw your attention to the modalities and mechanisms established by ASSECAA at the regional level. These



are in the form of periodic meetings and discussions conducted by Senates/Shoora and Equivalent Councils in Africa and Arab world, the adoption of joint activities to facilitate cooperation, exchange experiences, during which quality issues were raised. They include also the fifth retreat for members of ASSECAA, which was held in Bujumbura, Burundi last November, the Meeting of women parliamentarians held last February in Sudan. We have been keen to participate in the activities of international unions, support the proposals submitted by ASSECAA's members during their participation in the Meeting of the Inter-Parliamentary Union held last October.

In the framework of establishing a sustainable economic cooperation between Africa and Arab world, the General Secretariat's efforts have borne fruits in that it signed on October 14, 2013, a memorandum of understanding was signed between the GCC Federation of Chambers of Commerce and Industry and the Pan-African Chamber of Commerce and Industry. The memorandum aimed at initiating cooperation in various fields such as commerce, economic activities and investment as a mechanism for achieving comprehensive and sustainable development in the two regions.

Regarding the promotion of youth activities, the encouragement of scientific research and ASSECAA's Cup of Excellence constitute one of the distinctive qualitative events held during the past period. Added to this, is the signing of memorandums of understanding with research institutes and renowned universities for the purpose of supporting research activities and consultations in the fields of security and peace, among others".

"We, in Yemen are very much interested in the role ASSECAA is playing in establishing good Arab-African relations, and achieving our joint political and economic interests.

We, in fact, are encouraging this association being the sole institution bringing together Arab and African nations. This out of our keenness to accomplish the objectives for which this nascent Association was created. There is no doubt that the Association has achieved a lot of objectives since its inception, as its members believe in freedom and democracy, the conduct of periodic elections, inspiring the spirit of the age, and positively interacting with new variables".

"Given the above considerations and the requirements of the current, crucial phase, I hope your conference will help create a new dynamic to which your esteemed Association can make a major contribution at the following four levels:

At the political level, your Councils can help strengthen fledgling democracies, taking into account the specificity of each country.

On the economic front, and considering your Councils' competence and make up, I believe they can play a key role in



promoting an efficient development partnership between the Arab world and African countries, through concrete projects that are not restricted to basic infrastructure, but that also cover human development. Your assemblies and Councils can also help with the positioning of Member States; economies in preparation for the revamping and restructuring of the global economy. They can also help with the emergence of a system of governance, one which is not only more equitable and more balanced, but also one in which solidarity and human values feature more prominently.

On the cultural level, the interaction and interchange between Arab and African civilizations and the unstinting efforts Arabs and Africans are making to rise to the challenge of the knowledge and communication—based society, should prompt you to help set up an alliance of civilizations, promote inter-cultural, interfaith coexistence, confront extremism and terrorism—which cannot be ascribed to a given religion or a specific location and ensure respect for cultural diversity, since the latter enriches national identity and should not be a pretext for isolationism, intolerance and division.

The strategic policy sector remains a major area on which to focus your joint action. Many of the hotbeds of tension around the world today concern Africa and the Arab world and the most tragic of them is the ordeal and aggression suffered by our Palestinian brothers. This means your energies should be geared towards creating the right conditions for the constructive role that dialogue plays in promoting rapprochement, confidence and reconciliation, which are the ingredients for just, peaceful solutions; solutions that must preserve the sovereignty, national unity and territorial integrity of states and help prevent the squandering of energies and resources on artificial conflicts to which no solutions can, indeed, be found".
